You may submit an Archived Encipherment Private Key Retrieval Request Form by fax, postal mail, electronically signed e-mail or in-person at eSignTrust Registration Authority. If required, please submit the photocopy(ies) of identification document of the Requestor and the Certificate Subscriber.
